Limited Warranty

Multicom, Inc. (Multicom) warrants to the original purchaser that this product shall be free from defects in material or workmanship for one (1) year from the date of original purchase. Multicom, will at its sole option, either repair or replace (with a new or reconditioned product, as Multicom may determine) any product manufactured by Multicom which proves to be defective in materials or workmanship. Products that are not manufactured (but are resold) by Multicom carry the original warranty for such products, which may be longer or shorter than the Multicom's limited warranty. All sales of Refurbished Products are "as is" and are final.

To obtain service under this warranty, the instructions for "RETURN MATERIAL AUTHORIZATION REQUEST FORMS AND INSTRUCTIONS" and "REPAIR AND CREDIT RETURN POLICY" located on the Multicom web site (www.multicominc.com) must be followed. This warranty does not cover damage resulting from (i) use or installation other than in strict accordance with manufacturer's written instructions, (ii) disassembly or repair by someone other than the manufacturer or a manufacturer-authorized repair center, (iii) misuse, misapplication or abuse, (iv) alteration, (v) lack of reasonable care or (vi) force majeure, wind, ice, snow, rain, lightning, or any other weather conditions or acts of God.
